Annual Meeting Highlights

After introducing guests and first time resident attendees at the January 30, 2012 Annual Meeting, **President, Ken Rejko** summarized your Amberlea Board's following accomplishments during the past 2011 year:

- 1. With the expertise of **Directors Dave Dunlap** & **Deborah Macey**, we have expanded our website by being linked to other websites in the Dunedin Community. - 2. Our new front entrance feature and additional lighting was completed last year with the assistance of Board members and other Amberlea volunteers as shown in the website photographs as the work progressed.
- 3. **Directors Shaine Harvester** and **Joyce Kucek** began welcoming new Amberlea residents with a potted plant furnished by **Secretary**, **Terry Rejko** and an information packet containing Amberlea and Dunedin items of special interest.
- 4. We are continuing to develop a rapport with the city and staff that has enhanced our ability to resolve issues in a more timely fashion.
- 5. Thanks to **Vice President Bob Koechlin** we are now displaying an American flag on 24 appropriate recognized holidays and 2 holiday wreaths at the front entrance during the winter.
- 6. We have now achieved ongoing maintenance of both our irrigation system and landscaping at the front entrance due to the efforts of residents **Larry Chavez**, **Kevin Oldfield** and **Secretary**, **Terry Rejko**. At last we are slowly gaining control of the trash that is continuing to be dumped on the median island.
- 7. We have maintained a full Board of dedicated Officers and Directors which we thanked for their energetic and tireless efforts while serving our Amberlea and Dunedin communities throughout the past year.

Our featured program was presented by Pinellas County Sheriff's **Deputy Jan Wagner** and **Sergeant Denise Nestor**. Their entertaining presentation gave us helpful advice for protecting ourselves and our properties with crime prevention techniques and information. Each year at the Annual meeting we strive to have speakers of special interest to our homeowners that are topical and enlightening. If you have any suggestions or know of a speaker or program of interest to our group, please let us know well in advance of the meeting. **Deputy Jan Wagner** is retiring this year after 30 years of dedicated service to Pinellas County and especially the Dunedin Community. **Deputy Wagner** recently received an "OUTSTANDING SERVICE AWARD" from the Dunedin Rotary Club for her excellence of service record. She will be sorely missed.

After receiving many complaints of a few parked vehicles blocking drivers' views at the corner of Brook Drive and Brook Drive East, the city has taken action by alerting eight homeowners of the existing dangerous condition. Code Enforcement Director for Dunedin, **James Leavengood** has notified the owner of the oversized vehicle that habitually parks in this location and has had it removed. **Joan Rice**, **P.E.** of the Dunedin Transportation and Traffic Engineering Department said that "NO PARKING" signs will be the next step to resolve the difficulty with the remaining vehicles. Tweaking the Front Entrance

The board is in the planning stages of renovating portions of the two sides of the entry sidewalls with stucco repairs, painting and minor landscaping as a late spring or early summer project. We had hoped to include these items with our main entry project last year, but time and budget restraints precluded our forging ahead. Resident volunteer, **Ed Albuoy** has again agreed to provide his painting prowess after we pressure clean the walls and enlist the assistance of an outside contractor to perform the necessary stucco and masonry repairs. Following the planting of drought tolerant landscaping and project cleanup, there will be an appreciative cookout for the board members and other volunteers in conjunction with the next Board Meeting...date and time to be announced.

Devil in the Details

Since the completion of the entry sign last April, the entry island has been the recipient of a weekly supply of 6-8 beer cans left on the entry island by the **PHANTOM BUDWEISER GREMLIN**. Each week these cans have been placed in the same spot on the west side of the median strip near the north end. If you witness this occurring or have information regarding this disrespectful act, please notify our board in some fashion so it can be curtailed.

On a similar note, if any homeowner wants to place a sign such as a "FOR SALE" or "GARAGE SALE" at the front entrance, please place it on the grassy area on the east side of the entryway. We have sensitive irrigation and electrical lines underground in the median strip and your signs are detrimental to their well being and will cause unnecessary repairs. We will continue pulling such signs out of the ground when they are discovered. Thank you for your cooperation.
