Greetings to All

I have been writing the Amberlea quarterly newsletter since becoming your president in January of 2009. My goal has been to keep everyone informed of the ongoing issues affecting Amberlea and the procedures implemented by your Amberlea Board of Directors to resolve those issues. I hope this has been accomplished to your satisfaction. However, I believe we can improve and expand our Board's communications with homeowners by introducing an invaluable individual <u>Director's Comments</u> page in our newsletters.

At the time I became a Director in 2006, six of our current Officers and Directors were members of the Board. I was impressed that so many had stayed on as volunteers for so many years. I soon learned of the wealth of experience on our Board and of the many years of individual dedicated efforts to improve and govern Amberlea. Over the past forty years of our association's existence, many ideas have been implemented. Some ideas were carried out. Some were tried and discarded or kept and improved. This continuity and longevity of decisive leadership has enabled the Board to cautiously and prudently consider all aspects of any issue before plunging ahead.

I feel our Directors should and need to share their expertise and views pertaining to the Amberlea Community with all homeowners, not just the Board. To this end, I have asked **Director**, **Shaine Harvester** to be our first director to compose her thoughts and aspirations regarding Amberlea. Hurricane Preparedness

Now that the summer months are here, it's time to be certain of your personal preparedness for the erratic behavior of potential hurricanes forecast for this season. Fortunately, we in Amberlea and Dunedin have been spared from catastrophic hurricane damage for many years. I often hear people speak of personal hurricane damage they have encountered locally in recent years and wonder how they would react if a full blown category 3 or 4 hurricane would center its fury on Dunedin. Actually, the last hurricane to directly hit Dunedin was on October 25, 1921 and created what is now known as Hurricane Pass at the southern end of Honeymoon Island. It created a 10.5 ft. tide, rainfall of 11.73 inches, killed 5 people; and was described as having "moderate winds".

Our storms since then have not even produced the minimum wind speed of 75 miles per hour to be classified as a hurricane...yet people seem convinced that they have experienced and survived them firsthand. Unfortunately, this has led to a misguided sense of complacency and invulnerability on the part of the many people who do not evacuate from flood prone areas. I often wonder if they have even stocked emergency provisions for their personal safety until the last moment when our public emergency units are stressed to their capacity.

Let us each do our part for our own and our neighbors' safety by storing lawn chairs, trash cans or other potential flying debris ahead of time. Stock up on emergency water/foods, vital medicines and other supplies while maintaining contact with weather forecasts and bulletins as they are updated. Don't forget to check on and lend assistance to your neighbors if the need is present.

"No Parking" Signs

After receiving many complaints of several parked vehicles blocking drivers' views at the corner of Brook Drive and Brook Drive East, the city has taken action by installing "NO PARKING" signs on the west side of Brook Drive East near the corner. If you should continue to encounter this problem first hand, please alert the Sheriff's Department. Other complaints of parking issues of vehicles or boats should be directed to the City's Code Enforcement Official, **James Leavengood** at **727-298-3190** or our homeowners' association.
