Board Meeting

The quarterly board meeting of the officers and directors was held on August 6, 2009. Unfortunately, Directors Laura and Chris Tehan are moving out of state and will need to be replaced to cover Area 11. We thanked them for their many years of service to our Association and wished them and their newborn good luck in their new home.

Dave Dunlap updated us on the entrance renovations and we should see work commencing in the latter weeks of October (read further as to how this will impact our Annual Garage Sale). The continuing problem of unsightly vehicular parking by a few residents on the grassy portions of front yards was discussed at length. We are proceeding with placing notices on front doors reminding residents of the specific deed restriction violations that we find in non-compliance and will speak to homeowners if they are home. See the included sample form notice you may receive if you are in violation.

Shaine Harvester (Neighborhood Watch Chairperson) reported the status of her neighborhood watch efforts after her meeting with Deputy Sherri Roberts. Her report can be read later in this newsletter and all concerned residents should notify Shaine accordingly.

Greta Develle reported on the progress of our **Amberlea Homeowners Association Website**. After much discussion to eliminate any potential problems anticipated, we agreed to move ahead with Greta's suggestions and voted to have her implement our program with the website vendor. We formed a committee to work on the specifics of the contents of the website. Additional information will be addressed in the next newsletter prior to the Annual Meeting in January 2010. **I will continue to accept responses from residents to enable the board members to fine tune this website**. We are still anticipating the use of the website no later than January 2010.

We are continuing to seek interested homeowners to fill the Area Director vacancies for Areas 4, 5 and now 11. As stated before, contact me if you have a sense of community spirit and a willingness to share your views and ideas with your fellow board members. Without obligation, perhaps you could attend our next board meeting to see how we function.

Annual Garage Sale

The annual Amberlea Garage Sale scheduled for November 2009 has been canceled.

With the planned entranceway construction scheduled to be in progress at that time, concerns over last year's parking and this year's anticipated construction conditions has given us pause to continue this event as in years past. This event has not been without its share of problems. Complaints of blocked streets from careless parking and pedestrians idly walking in front of moving cars has created potentially dangerous situations your Board is very concerned about from a moral and legal viewpoint. It has been suggested to hire off-duty policemen and/or provide road cones to direct traffic and parking to ease the situation. This of course would necessitate extra expenditures from the Association. This increase in fees could be passed on to those participating even though there are those who pay no fees whatsoever. Is this the best use of Association monies collected through our dues when the garage sale benefits a minority of the Amberlea residents? We don't think so. It is everyone's right to host their own garage sale if and when they want provided they comply with the city' regulations.

Dave Dunlap has been most generous of his time by single-handedly filing the required permits with the city, issuing the flyers, placing the advertising, collecting the fees from participants, chasing down the non-payers who benefited from our advertising; and, directing rampant parking and traffic snarls over the past several years. He cannot nor do we encourage him to continue to do so. Therefore, if we are to continue this event resuming next year, we will need the assistance of perhaps a dozen or so non-Board members to cover these various categories and participate by serving on a planning and implementation committee.

The Board is open to suggestions from any and all concerned residents and your comments regarding this matter will be appreciated.

A tentative date for our next Board meeting is scheduled for 7:00 PM-Thursday, November 5, 2009 at the Rejko residence ([address redacted]). Officers and Directors please respond for confirmation.

Most of our residents have a sense of compliance and wish to reside in a harmonious community of well intentioned and considerate neighbors. They expect us all to preserve the integrity of Amberlea. They share a common goal of preserving our properties' values by maintaining Amberlea as an attractive place to live.
